- (9) Arrangements for the reservation of the premises shall not be accepted for more than one (1) year in advance.
- (10) Reservations must be made a minimum of seventy-two (72) hours in advance. Reservations are on a "first come", "first serve" basis.
- (11) No reservations will be accepted until January 1 for that calendar year.
- (12) The Village shall not be responsible for loss or damage to any personal property or equipment of the User or the User's guests.
- (13) User herby agrees to the following rules regarding the use of the premises:
 - A. No alcoholic beverages shall be served, used, or consumed on the premises;
 - B. No drug use on the premises;
 - C. All groups using the premises shall have adequate ADULT supervision at all times;
 - D. In addition, all park and playground rules and regulations shall be adhered to, a copy of which is attached as Exhibit 1.
 - E. Wolf's Prairie Playground IS NOT included in this reservation and is open to the public.
- (14) No resident, organization, family, company, or group may use or reserve either pavilion for two (2) consecutive weekends in a row.
- (15) All local zoning and use ordinances will be followed in regard to use of Park Property.

Failure to comply with the rules and regulations as set forth herein could result in immediate cancellation of this reservation by the Council.

RULES FOR USE OF VILLAGE PARKS PROPERTY

- 1. Parks are open from dawn to 11:00 pm, unless otherwise posted.
- 2. Pavilions open to the public UNLESS they are reserved as posted on the reservation board. The pavilions may be reserved by Village of Berrien Springs residents only. Reservations may be made by visiting the Village Hall and completing an agreement at least 72 hours in advance.
- 3. No illegal drugs or alcoholic beverages allowed, except at Shamrock Park's paid camp sites where alcohol only is permitted.
- 4. Smoking is prohibited inside Wolf's Prairie Playground at Grove Park. It is strongly discouraged elsewhere in the parks.
- 5. A permit, obtained from the Village Council, must be acquired to offer, or exchange for sale any article or thing; any hawking, peddling, or soliciting; take up any collection or solicit or receive contributions of money or anything of value in a park.
- 6. No open fires.
- 7. No littering. No grill debris dumping.
- 8. No firearms or fireworks.
- 9. No camping (except Shamrock Park).
- 10. All dogs must be on a leash. Dogs are not allowed in the playground at Grove Park. All dog owners must clean up after their animal.
- 11. No snowmobiling or horseback riding.
- 12. Pedestrian traffic is only allowed in the parks. No motorized vehicles, bicycles, skateboards, scooters, etc. are allowed off roadways.
- 13. Any unauthorized vehicle remaining in a park after hours will be towed away at the owner's expense.

FAILURE TO COMPLY WITH THESE RULES MAY RESULT IN LIMITED OR DENIED PARK PRIVILEGES.

These rules are in reference to the adopted Code of Ordinances, Village of Berrien Springs, Michigan.
